The most substantial and significant specific workstream that Caplor Horizons undertook was the renewal of AECB strategy

Lorna Pearcey and Ian Williams facilitated this. We have had very positive feedback about strategy that emerged from this process.

For instance, with our members it has been helpful. We hear key phrases in the strategy, such as being 'relentlessly optimistic', repeated. Also some of the elements have been picked up and used by members in their own materials.

Part of the new strategy was a greater focus on thought leadership. As it became a commitment within the strategy, greater attention has subsequently been devoted to it, including writing some technical papers. Having such a focus has been useful.

Moreover, in developing our strategy, we emphasized the importance of working collaboratively: this has been helpful in cutting through competition in the building sector and finding new ways of working together.

The contribution of Caplor Horizons has been extremely helpful to the AECB in a variety of ways that the organization would not have otherwise had access to. The manner in which the Advisors share their experience and knowledge so generously for the good of others is also a great inspiration. It is a great model and I continue to consider how aspects of it could
